### **ENTRIES:**

Entries will be completed on Texas 4-HOnline under the event "2024 District 10 Record book Judging."

- ➤ Each entry will be \$5.00. **All District Record Book entries must be submitted on 4HOnline:** 
  - Early Registration Period: June 1 25, 2024 \$5.00 per book submitted
  - Late Registration Period: June 26-28, 2024 \$5.00 per book submitted +\$25 Late Fee per book.
  - o County Office Certification Deadline: Tuesday, July 2, 2024
  - o No late registrations will be accepted after the final late registration deadline of June 28, 2024.
  - Incomplete registrations (click <u>HERE</u> to view "How to complete an incomplete Registration") will be deleted after the final deadline of registration. If you do not complete your incomplete registrations prior to the final deadline, it will not be accepted by the District Office.
  - Once the registration is approved, no refunds will be given for any District Registrations.

# **SUBMISSION GUIDLINES:**

County Extension Agents will need to bring their county's physical record books to the event on **July**11th by 8:30 am to sort them into the correct categories. Each Record book should have the following:

- 1. On the front cover of the Record book folder, attach a 3x5 index card or "cover page" with the following information legibly printed or typed:
  - Name of 4-H Member
  - County
  - Age Division
  - Category
  - PLEASE MAKE SURE YOU UPDATE THE CARDS FROM THE PREVIOUS YEAR!
- The Record Book <u>Check Sheet</u> is an <u>OPTIONAL</u> single page which can be placed loosely at the front of the Record Book. <u>The check sheet will not be required for those record books advancing to</u> <u>District.</u>
- 3. The "Personal Information Page" should be signed by member and parent. (DOWNLOAD FORMS)


