DATE: Saturday, April 25, 2026

LOCATION: Wilson County Expo Center ([435 TX-97, Floresville, TX 78114](#))

SCHEDULE: A shooting schedule will be sent to counties after registration has closed and all entries have been processed. Participants are required to shoot during their assigned time of the published schedule. **IMPORTANT, PLEASE READ:** If your shooter requires a specific time slot (AM or PM) or your team uses shared equipment that limits the number of shooters per relay; **all requests MUST be submitted in the "Accommodations" text box when you register on 4HOnline to be considered for the schedule.** To accommodate all requests, it may be necessary to schedule multiple teams, from different age divisions, in the same county/club to shoot at the same time. If you request a time accommodation after the shooting schedule has been published, you are **NOT** guaranteed to be moved to your requested time slot

- **Due to increased participation in the Smallbore Rifle Contest, relays may be available at the discretion of the committee on Friday Evening (April 24, 2026).** Participants may request to shoot on Friday evening if they have legitimate restrictions (which will need to be documented during registration) that prevents them from shooting on Saturday. All requests will be considered by the Smallbore Rifle Committee but are not guaranteed due to limited availability of slots.

ABOUT THIS CONTEST: District 10 will be conducting the 4-H Smallbore Rifle Contest on Saturday, April 25, 2026 at the Wilson County Expo Center in Floresville. **This is an Indoor – 50-foot competition.** Wilson County 4-H will be generously hosting a concession stand during the contests. Please visit the concession stand to support the local club hosting the competition.

CONTEST TYPE: District Qualifying

1. Counties may enter as many teams as they wish in each age division.
2. Junior, Junior-Intermediate, Intermediate and Senior age divisions may enter up to two (2) individuals in the contest and individuals will be eligible for high point individual awards.
3. The top 1st – 3rd place Senior Smallbore Rifle teams & the 1st – 3rd high point individuals (only if they did not belong to a qualifying team) will qualify to compete in the Texas 4-H Roundup State Indoor Rifle Match in June.

MODIFIED AGE DIVISIONS: There will be four age divisions. Division is determined by the 4-Her's grade as of August 31, 2024.

- **Junior – 3rd-5th Grade**
- **Junior Intermediate – 6th-7th Grade**
- **Intermediate – 8th Grade**
- **Senior – 9th-12th Grade**

CONTEST STRUCTURE

Team or Individual: Smallbore Rifle teams must be comprised of 3-4 youth in the same age division **unless they are a Junior contestant moving up to a Junior-Intermediate Team or a Junior-Intermediate contestant moving up to an Intermediate Team.* For a four-person team, the lowest score in each position will be dropped. This contest also allows individual competitors. **Please note that only two individuals per age division will be allowed at District.* If you have three individuals, they will be required to combine into a team to compete at District.

CONTEST RULES

1. **Equipment & Materials:** Contestants will be required to provide their own firearms & ammunition.
 - Any rifle - Rifle must conform to NRA 3.2 rule. Any safe .22 caliber rimfire rifle chambered for .22 Short, .22 Long or .22 Long Rifle cartridges may be used in Smallbore 3-position Rifle competitions. No restriction is placed on barrel length or overall weight of the rifle and accessories. No part of the rifle or any attachment may extend more than three (3) inches (7.62 cm) beyond the rear of the shooter's shoulder. Triggers must not be subject to accidental discharge. The same rifle must be used throughout a match except in the case of malfunction or a disabled rifle. In either event the competitor may change rifles with the permission of the range officer.
 - Ammunition - At least 100 rounds per contestant for sighting and scoring. **Per rule 3.7 of the State 3-Position Smallbore Rifle Rules:** Factory loaded solid .22lr load not to exceed 40 grains with a Maximum Velocity: 1280fps. Hollow Points, Hot, hyper-velocity loads are not permitted.
 - Eye/Ear Protection is required by everyone on the range (competitors, coaches, & range officer.)
 - Rifle rests - Seniors and Intermediates are recommended to use rifle rests between firing in the standing position.
2. **Targets:** Orion targets will be used for all competitors. Targets will be provided for each team member, for each firing position. You do not need to bring targets. Targets will be coded and distributed to the coach at registration.
3. **Scoring:** Scoring will be done by the Orion Electronic Scoring system. Any cross-over shots, excessive shots, or sighting shots out of sighting bulls, etc. must be verified and initialed by the range officer before the target is removed from the backstop. Once removed from the backstop, special consideration will not be given. It is the responsibility of the coach to verify these irregularities and bring them to the attention of the range officer at the time of occurrence and to have the range officer make a notation on the target before it is removed from the backstop. Also, **contrary to State Rifle Contest Rules** which enforces NRA Rule 9.8B, stating “participants will go for the record shots once a sighter is out of the sighter ring”, the District will not enforce the rule but coaches must report sighters out of the ring to the range officer. **The decision on scoring challenges will be accomplished using the “protest” feature in the Orion system, not using a plug as stated in NRA rule 10.10.6.1.**
4. **Challenge Timeline:** Any challenges to scoring must now be made within 15 minutes from the point that targets are scored & placed on the table for review. After 15 minutes elapses, challenges will no longer be accepted.
5. **Participant Liability Waiver:** A Texas 4-H WAIVER, INDEMNIFICATION, AND MEDICAL TREATMENT AUTHORIZATION FORM (Download [HERE](#)) will be **required** for every participant. It must be completed and signed by both the contestant and a parent/legal guardian prior to participation. **This form MUST be submitted with your registration on 4HOnline.**

6. **Range Officer:** The range officer will run the range, monitor safety and conduct, verify targets, and assist shooters, as necessary. The range officer will make note of cross-over shots, excessive shots, sighting shots out of sighting bull or other irregularities at the time they occur and make notations on targets to facilitate the scoring process. The range officer will receive protests and decide on whether to uphold the protest. He/she may choose to consult with the head scorer to pass judgment on a protest concerning scoring.
7. **Safety:** All firearms, whether being carried, at rest in vehicles near the range, or at rest, will be unloaded and will have bolts open except when on firing line in the process of firing. All firearms are required to have “open bolt indicators” (OBI’s) until called to firing point and preparation time, when a match is completed and when cease fire is called. All rifles will remain in a case or appropriate rifle stand at all times until the participants are instructed by the range officer to take them to the firing line. A total of four coaches will be allowed on the firing line with each four-member team. A safety committee consisting of one person per participating county will be appointed by the safety committee chairpersons prior to the contest, with three people on duty at any one time. It will be the responsibility of these persons to monitor the safe conduct and handling of firearms of all persons present in and around the contest location and to either immediately correct the situation or report the infraction to the range officer. **REMINDER!** Safety Orientations are **MANDATORY** regardless of time accommodations. All participants must attend a safety orientation prior to shooting. An orientation will be held before the Friday relay(s), on Saturday morning, and Saturday afternoon.
8. **Conduct:** Violation of accepted rules of safety and conduct on the range will, at the discretion of the range officer, disqualify a contestant, or in the case of a coach, result in the removal of the coach from the firing line.
9. **District Rules:** The following rules have been set by the District Shooting Sports Committee:
- Coaches will be responsible for safety of equipment (e.g., Trigger pull); however, the selected range officer will have the authority to deem something unsafe and make corrections at time of the contest.
 - NRA rules will be followed except as noted. State rules apply at District Contest.
 - Adequate and appropriate eye and ear protection is required for all persons on the firing line during live firing at all 4-H shooting sports events and activities at all levels.
 - There will be a charge of \$1.00 per challenge of target scoring. Juniors, Junior Intermediates, and Intermediates will be allowed to have a coach present during the challenge. Senior shooters must challenge by themselves.
 - Firing Positions for each age division are as follows:

10. **Awards** will be held at the conclusion of the contest.
